This is your Sample Ballot for the June 10, 2025, State Representative District 3 Special Election.

- Only residents of State Representative District 3 registered to vote on or before May 12, 2025, are eligible to vote in this election.
- If you have moved since you last voted, please check with the Supervisor of Elections Office to verify if you are still eligible for this election.
- **Move your polling place to your living room.** Request your ballot by contacting the Supervisor of Elections office via telephone, email, mail, in person or by visiting our website. According to Florida Law, all Vote-By-Mail requests expire after each General Election. That means that at the end of 2024 all existing requests we had on file expired. To continue voting by mail in 2025 and 2026, voters will need to renew their request. Vote-By-Mail ballots must be returned to the Supervisor of Elections Office by 7pm on Election Day in order to be counted. The last day to request a ballot is May 29, 2025.
- **Early voting** will be held 8:30am - 4:30pm Saturday, May 31 – Saturday, June 7, at the following location:
